Mission Statement

Life Services is a Christ-centered organization dedicated to the sanctity of life at conception. We offer hope, truth, medical care, and support from a Biblical perspective to anyone impacted by an unplanned pregnancy, abortion or sexual trauma, helping them find healing, choose life and encouraging a personal relationship with Jesus Christ.

Statement of Faith

1. We believe the Bible to be the inspired, the only infallible, authoritative Word of God.
2. We believe that there is one God, eternally existent in three persons: Father, Son, and Holy Spirit.
3. We believe in the deity of our Lord Jesus Christ, in His virgin birth, in His sinless life, in His miracles, in His vicarious and atoning death through His shed blood, in His bodily resurrection, in His ascension to the right hand of the Father, and in His personal return in power and glory.
4. We believe that for the salvation of lost and sinful man, regeneration by the Holy Spirit is absolutely essential, and that this salvation is received through faith in Jesus Christ as Savior and Lord and not as a result of good works.
5. We believe in the present ministry of the Holy Spirit by whose indwelling the Christian is enabled to live a godly life and to perform good works.
6. We believe in the resurrection of both the saved and the lost; they that are saved unto the resurrection of life and they that are lost unto the resurrection of damnation.
7. We believe in the spiritual unity of believers in our Lord Jesus Christ.

Statement of Principle

1. LIFE SERVICES, is an outreach ministry of Jesus Christ through His church. Therefore, LIFE SERVICES, embodied in its volunteers, is committed to presenting the gospel of our Lord to those experiencing unplanned pregnancies - both in word and in deed. Commensurate with this purpose, those who labor as LIFE SERVICES Board members, staff, and volunteers, are expected to know Jesus Christ as their Savior and Lord.
2. LIFE SERVICES is committed to providing its clients with accurate and complete information about both prenatal development and abortion.
3. LIFE SERVICES is committed to integrity in dealing with clients, earning their trust and providing promised information and services, and denounces any form of deception in its corporate advertising or individual conversations with its clients.
4. All ministries of LIFE SERVICES are committed to assisting women to carry their pregnancies to term by providing emotional support and practical assistance. Through the provision of God's people and the community at large, women may face the future with hope and plan constructively for themselves and their babies.
5. LIFE SERVICES does not discriminate in providing services because of race, creed, color, national origin, age, or marital status of its clients.
6. LIFE SERVICES does not recommend, provide, or refer for abortion or abortifacients.
7. LIFE SERVICES offers most services free of charge except as clearly disclosed in advance to potential clients. For example, lab fees may be incurred through third party laboratories used by Life Services. Additionally, a small fee for residential care in Life Services' Maternity Home is required.
8. LIFE SERVICES is committed to creating an awareness within the local community of the needs of pregnant women and of the fact that abortions only compound human need rather than resolve it.
9. LIFE SERVICES does not recommend, provide or refer single women for contraceptives. All clients, single or married are encouraged toward sexual integrity.
10. LIFE SERVICES recognizes the validity of adoption as one alternative to abortion, but is not biased toward adoption when compared to other life-saving alternatives. LIFE SERVICES is independent of adoption agencies, relating to them in the same manner as to other helpful referral sources. LIFE SERVICES/Crisis Pregnancy Centers receives no payment of any kind from these agencies, does not enter in contractual relationships with them, and does not share combined office space. Adoption agencies are not established under the auspices of LIFE SERVICES nor do they initiate or facilitate independent adoptions. Clients who are interested in private adoptions are referred to independent adoption attorneys for assistance.

Statement on Marriage, Gender and Sexuality

We believe that by design, God wonderfully and immutably creates each person as male or female. These two distinct, complementary genders together reflect the image and nature of God. Except in the rare case of those born intersex, rejection of one's biological sex is a rejection and distortion of God's design for that person. (Gen 1:26-27)

We believe that the term "marriage" has only one meaning: the uniting of one man and one woman in a single, exclusive union, as delineated in Scripture (Gen 2:18-25). We believe that God intends sexual intimacy to occur only between a man and a woman who are married to each other. We believe that God's design for sexual intimacy is that no sexual activity be engaged in outside of a marriage between a man and a woman (1 Cor 6:18; 7:2-5; Heb 13:4).

We believe that any form of sexual immorality (including adultery, fornication, homosexuality, bisexual conduct, bestiality, incest, and use of pornography) is outside of God's design for sexual intimacy (Matt 15:18-20; 1 Cor 6:9-11).

While we affirm God's design for sexual identity and sexual intimacy is clear, we acknowledge that achieving and maintaining sexual integrity can be a struggle. Therefore, we extend love and compassion to those caught in the trap of immoral sexual practices. We extend love and compassion to those who struggle with homosexual attraction and identification. We extend love and compassion to those whose sexual self-understanding is shaped by a distressing conflict between their biological sex and their gender identity (Eph 4:17-18; 1 Tim 1:13-17).

We believe that every person must be afforded compassion, love, kindness, respect, and dignity. Hateful and harassing behavior or attitudes directed toward any individual are to be rejected and are not in accord with Scripture nor are they acceptable practices of representatives of Life Services of Spokane (Mark 12:28-31; Luke 6:27-38).

We believe that in order to preserve the function and integrity of Life Services of Spokane as a localized representation of the collective Body of Christ, and to provide a biblical role model to patients, clients, and the community, it is imperative that all persons employed by Life Services in any capacity, or who serve as volunteers, agree to and abide by this Statement on Marriage, Gender, and Sexuality (Matt 5:16; Phil 2:14-16; 1 Thess 5:22-24).

We believe that God offers redemption and restoration to all who acknowledge and turn away from their sin, seeking His mercy and forgiveness through Jesus Christ (Acts 3:19-21; Rom 10:9-10; 1 Cor 6:9-11).
